The long awaiting replacement of the bridge is set to begin 2/26/2018 with PENNDOT posting the detour route for the approximate 6 month long process. Aqua provided their schedule for connections to the new main to take place 2/21 through 2/24. They have requested police to be posted at the ends of their road closure from 2/24 midnight to six am.

FY 2017 CDBG - Glenolden Park Trail

Three (3) different options for route have been provided to the Borough Manager for review. Electronic versions will be forwarded as well.

Road Program

On January 25th, we received notification the Partial Completion Report for the 2009 Loan Repayment was approved by PENNDOT.

MS4

We performed inspections of existing BMP's and have drafted deficiency letters to send to the various property owners.

We met with the Collaborative to discuss next steps. Norwood has withdrawn from the PRP and the Agreement is being re-worked accordingly. That should be completed within the next few weeks.

At Council President's request I gave a brief overview of the MS-4 permit the Borough has held since 2003 and how it has evolved to the next permit renewal period that requires physical projects to reduce sediment loads on existing stream. These projects will be completed through the Eastern Delaware County Stormwater Collaborative

Glenolden Park - Lower Section

We met with the Borough Manager regarding the preparation of a sketch plan and estimate for ADA access for submission of a Grant Application to fund the improvements.
